Mr. Stevenson advised the Board of the situation involving Issue 32 wherein inconsistent language appeared in the Resolution ordering the Board to conduct an Election in Miami Township, Ohio. As a result, there were several precincts included in that election that should not have been included; specifically, the incorporated Villages in Miami Township. A temporary restraining order was issued, ordering the Board not to release the results of that election on Election Day until further order of the Court. Mr. Stevenson requests the Board to authorize his office to sign an agreed order making sure that the precincts that should not be included in that election are excluded from that election.

Mr. Triantafilou made a motion to authorize counsel to execute said agreed order on behalf of the Board; Mr. Faux seconded. The motion passed unanimously.

VI. OTHER BUSINESS

Staff recommended that an explanation of the Court order not to release the results of Issue 32 Election be posted to the website.

The Board was reminded of the proposals received for new voting booths. Staff has narrowed the selection down to two models. The Board was advised that each of the two types was sent to two different polling locations for use in the election together with surveys for poll worker feedback on the voting booths. The two locations are St. Lawrence in Price Hill and St. Bernard (Municipal Building).

Chairman Burke allowed for comments from the audience whereupon Mr. J. Joseph Janus addressed the Board with some general questions for Staff.
