## IV. PROTEST HEARING: PETITION FOR COUNTY ZONING REFERENDUM RESOLUTION AUTHORIZING A ZONING MAP AMENDMENT FOR CASE: COLUMBIA 2019-01: CAMPBRIDGE RETAIL FROM "C" TO "EE": PLANNED RETAIL

The Board was advised of the following timeline:

October 14, 2019:

Petition for a County Zoning Referendum submitted to BOE

• October 16, 2019:

Board staff noticed the Hamilton County BOCC that the

petition contained the required number of valid signatures

October 24, 2019:

BOCC adopted a Resolution directing the BOE to submit the referendum to the electors of Columbia Twp. at the March

27, 2020 Election

- October 30, 2019: Protest regarding the referendum petition filed with the BOE on behalf of Woeste Investments Ltd.
- November 12, 2019: Response to protest filed with the BOE on behalf of petitioners.

William Fecher, Esq., representing Woeste Investments Ltd. addressed the Board and set forth their protest of the referendum petition submitted by a number of residents of Columbia Township which seeks to place on the March 17, 2020 ballot the zoning map and Resolution adopted by the Hamilton County Board of Commissioners on September 19, 2019. A Transcript of the meeting is attached hereto for reference.

Mr. Triantafilou, upon listening to the remarks of counsel, disclosed that his firm represents Columbia Twp. and questioned the involvement of Columbia Township in this dispute. Although assured that this issue does not directly involve Columbia Township, Mr. Triantafilou, after consultation with legal counsel and attorneys from both parties, recused himself from the proceedings in this matter.

Kathleen Ryan, Esq., representing the petitioners addressed the Board to reaffirm the petition as filed and to counter the objections made on behalf of Woeste Investments Ltd. A Transcript of the meeting is attached hereto for reference.

Mr. Fecher re-addressed the Board to rebut points made by Ms. Ryan.

A discussion between the Board members and counsel continued throughout.

Mr. Gerhardt made a motion to enter into Executive Session for the purpose of discussion with Counsel; Mr. Faux seconded. Ms. McFarlin –aye; Mr. Faux –aye; Mr. Gerhardt –aye; Mr. Triantafilou abstained, whereupon the Board entered executive session at 12:47pm.

Mr. Gerhardt made a motion to return from Executive Session; Mr. Faux seconded. Ms. McFarlin –aye; Mr. Faux –aye; Mr. Gerhardt –aye, whereupon the Board returned to regular session at 1pm.

The Board asked attorneys from both sides to submit written arguments not later than 4pm on Thursday, November 21, 2019. The Board agreed to meet on Tuesday, December 3, 2019 at 9am for decision.

There being no further business to come before the Board, Mr. Gerhardt made a motion to adjourn; Mr. Faux seconded. The motion passed unanimously.
