

**HAMILTON COUNTY BOARD OF ELECTIONS
MEETING HELD
NOVEMBER 26, 2018 at 8:30AM**

The meeting of the Hamilton County Board of Elections was called to order at 8:30am by Chairman Burke. Present were members Mr. Faux and Mr. Gerhardt. Also present: Director Sherry Poland and Deputy Director Sally Krisel and David Stevenson and Cooper Bowen with the Hamilton County Prosecutor's Office.

Chairman Burke noted that proper notice was duly provided as required by O.R.C. 121.22.

I. CONDUCT RANDOM DRAW OF PRECINCTS FOR THE AUTOMATIC RECOUNT – STATE REPRESENTATIVE 28TH DISTRICT

In the presence of the Board and the public in attendance, Staff conducted a random draw of the polling locations to be included in the hand count for the State Representative 28th District contest. The number to be reached for the hand count is 2826 votes cast. Attached is the list of polling locations randomly selected for the hand count.

The Board was reminded that the recount would begin on Friday, November 30, 2018 at 8:30 am in Room C. It is expected the recount will be completed by 4pm.

II. CONDUCT RANDOM DRAW OF PRECINCTS FOR THE AUDIT

The Board was advised that, per Secretary of State Directive, the audit must include two statewide contests selected by the Secretary of State: Governor and Treasurer. The Board must randomly select a third contest to audit; a county-wide candidate contest.

Staff conducted a random draw of contests and selected the following contest to be included in the Audit:

Thomas O. Beridon/Curt C. Hartman – Judge of the Court of Common Pleas

Staff conducted a random draw of polling locations to be included in the hand count for the audit. The number to be reached for the hand count is 17,194 votes cast. Attached is the list of polling locations randomly selected for the hand count.


There being no further business to come before the Board, Mr. Triantafilou made a motion to adjourn; Mr. Faux seconded. The motion passed unanimously.
