# HAMILTON COUNTY BOARD OF ELECTIONS MEETING HELD APRIL 28, 2020 at 6:30PM

The meeting of the Hamilton County Board of Elections was called to order at 6:30pm by Chair Gwen McFarlin. Present were members Mr. Triantafilou, Mr. Faux and Mr. Gerhardt. Also present: Director Sherry Poland and Deputy Director Sally Krisel and David Stevenson with the Hamilton County Prosecutor's office. Due to COVID-19 and Ohio Governor Mike DeWine's stay at home order, the meeting was live streamed for public viewing.

Ms. McFarlin noted that proper notice was duly provided as required by O.R.C. 121.22. Ms. McFarlin opened the meeting with the Pledge of Allegiance.

#### I. APPROVE BOARD MEETING MINUTES: APRIL 22, 2020

Mr. Triantafilou asked that the minutes for April 22, 2020 reflect the statement by Mr. Stevenson which properly indicated the reason for the Executive session, which was "personnel matters and matters of compensation". With this amendment to the minutes, Mr. Triantafilou made a motion to approve the Board Meeting Minutes for April 22, 2020; Mr. Faux seconded. The motion passed unanimously.
