HAMILTON COUNTY BOARD OF ELECTIONS **MEETING HELD NOVEMBER 16, 2020 at 12PM**

The meeting of the Hamilton County Board of Elections was called to order at 12pm by Chair Gwen McFarlin. Present were members Mr. Triantafilou, Mr. Gerhardt and Mr. Faux. Also present: Director Sherry Poland and Deputy Director Sally Krisel and David Stevenson and Cooper Bowen with the Hamilton County Prosecutor's office. Due to Social Distancing and limited space in the Board Meeting Room, the meeting was live streamed for public viewing.

Ms. McFarlin noted that proper notice was duly provided as required by O.R.C. 121.22. Ms. McFarlin opened the meeting with the Pledge of Allegiance.

*The Board was advised that two completed Provisional Envelopes were cast in the same precinct, same polling location within minutes of each other. No notes were included to indicate the reason for this, however Staff has surmised perhaps one was intended to be a soiled and defaced/voided ballot. As there is no way to determine this prior to opening the envelope, Staff is seeking instruction from the Board as to which Provisional Envelope should be counted; the envelopes have been provided a "P" number by Staff.

Mr. Stevenson offered the following guidance: Open the lowest "P" number first; if the ballot can be counted (not voided in Precinct) then it is counted and the second envelope is rejected (unopened). If the first is voided, it is rejected and the second is opened and counted.

The Board inquired regarding ballots received after the Election and were advised that approximately 1,000 ballots were received after Election Day and were postmarked timely, including 11S forms (forms sent to voter by Staff to cure a deficiency on a timely returned Absentee ballot identification envelope).

The Board was further advised that statistics regarding Ballots received after the deadline would be included as part of the reports due to the Ohio Secretary of State.

There being no further business to come before the Board, Mr. Triantafilou made a motion to stand in recess; Mr. Faux seconded. The motion passed unanimously.
