I. CERTIFY: NOVEMBER 3, 2020 PRESIDENTIAL GENERAL ELECTION OFFICIAL RESULTS

Mr. Triantafilou made a motion to Certify the November 3, 2020 Presidential General Election results; Mr. Faux seconded. The motion passed unanimously.

II. DECLARE RECOUNTS, IF NECESSARY

The Board was advised that no recounts were required.

III. CONDUCT RANDOM DRAW OF CONTEST TO BE AUDITED

The Board was advised that three contests are to be audited. Included will be two contests as chosen by the Ohio Secretary of State: 1. President and 2. Justice of the Supreme Court, full term commencing January 1, 2021. The third contest will be a county-wide contest and will be determined by random draw. A bipartisan team conducted said draw and determined the contest to be Judge of The Court of Common Pleas (Drug Court Division).

Staff recommends the Board allow the audit to take place by units by auditing polling locations; random draw of said polling locations by bipartisan teams on Thursday, November 19, 2020; audit to begin December 2, 2020 at 8:30am.

Mr. Triantafilou made a motion to accept the Staff recommendation concerning the Audit; Mr. Faux seconded. The motion passed unanimously.

Ms. Poland reminded the Board that Veterans Day is a Board recognized holiday that Staff was unable to take due to the ongoing post Election activity. Staff is requesting the Board grant Wednesday, November 25th as a holiday for staff this year in exchange for Veterans Day.

Mr. Triantafilou made a motion to accept the staff recommendation for a staff holiday on Wednesday, November 25th; Mr. Faux seconded. The motion passed unanimously.
