I understand that if I do not provide the board with all of the required information, my application cannot be processed.

NEXT STEPS

- Once the board of elections receives your absentee vote by mail application, the board will process your request and mail your ballot beginning October 11th, 2023 to your address.
- You can track your application and your ballot online at votehamiltoncountyohio.gov
- If you return your absentee ballot by mail, it must be postmarked no later than
 November 6th, 2023 and received by the board of elections no later than
 November 13th, 2023. By state law, a postmark does NOT include a date marked
 by a postage evidence system such as a postage meter.
- If you return your ballot to the board in person, or if a near relative* delivers it for you, the board of elections must receive your ballot no later than **7:30 p.m. on Election Day.**
- For members of the uniformed services or voters outside of the United States ONLY, ballots must be received by **November 13th**, **2023**. Sign your identification envelope by the close of polls on Election Day or return in person by **7:30 p.m. on Election Day**.

^{*}Near relative includes the voter's spouse or the voter's father, mother, father-in-law, mother-in-law, grandfather, grandmother, brother, or sister of the whole or half blood, or the son, daughter, adopting parent, adopted child, stepparent, stepchild, uncle, aunt, nephew, or niece.
