   This form must be received by the Board of Elections by 8:30pm on March 12, 2024.

## **NEXT STEPS**

- Once the board of elections receives your absentee vote by mail application, the board will process your request and mail your ballot beginning February 21st, 2024 to your address.
- You can track your application and your ballot online at votehamiltoncountyohio.gov
- If you return your absentee ballot by mail, it must be postmarked no later than
   March 18<sup>th</sup>, 2024 and received by the board of elections no later than
   March 23<sup>rd</sup>, 2024. By state law, a postmark does NOT include a date marked by a
   postage evidence system such as a postage meter.
- If you return your ballot to the board in person, or if a near relative\* delivers it for you, the board of elections must receive your ballot no later than 7:30 p.m. on Election Day.
- For members of the uniformed services or voters outside of the United States ONLY, ballots must be received by **March 23<sup>rd</sup>, 2024**. Sign your identification envelope by the close of polls on Election Day or return in person by **7:30 p.m. on Election Day**.

<sup>\*</sup>Near relative includes the voter's spouse or the voter's father, mother, father-in-law, mother-in-law, grandfather, grandmother, brother, or sister of the whole or half blood, or the son, daughter, adopting parent, adopted child, stepparent, stepchild, uncle, aunt, nephew, or niece.
