The copy of the photo ID must include images of the **front and back**, except for a passport which must include the passport's identification page.

- I understand that, per Ohio law, the Board of Elections must receive this request no later than **8:30pm on October 29th, 2024.**
- I understand that if an absentee ballot is mailed to me and I change my mind and go to my polling place to vote on Election Day, I will be required to vote a provisional ballot.
- I understand that if I do not provide the Board with all of the required information, my application cannot be processed.
- I hereby declare, under penalty of election falsification, that I am a qualified elector and the statements above are true.

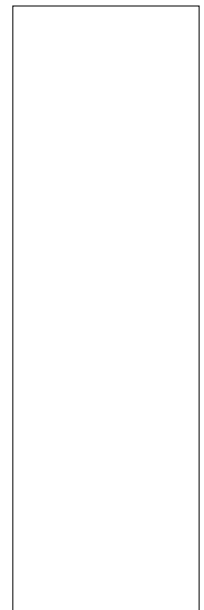

TO ENSURE YOUR ABSENTEE BALLOT REQUEST IS RECEIVED, PLEASE DO THE FOLLOWING:

- Complete all fields.
- Sign and date your application.
- Mail the completed application, or return using our 24-hour secure drop box at the Hamilton County Board of Elections, 4700 Smith Rd., Cincinnati, OH 45212. This form must be received by the Board of Elections by **8:30 p.m. on October 29th, 2024.**

NEXT STEPS

- Once the Board of Elections receives your absentee vote by mail application, the board will process your request and mail your ballot beginning **October 8th, 2024** to your address.
- You can track your application and your ballot online at votehamiltoncountyohio.gov
- If you return your absentee ballot by mail, it must be postmarked no later than **November 4th, 2024** and received by the Board of Elections no later than **November 9th, 2024**. By state law, a postmark does NOT include a date marked by a postage evidence system such as a postage meter.
- If you return your ballot to the Board in person, or if a near relative* delivers it for you, the Board of Elections must receive your ballot no later than **7:30 p.m. on Election Day**.
- For members of the uniformed services or voters outside of the United States ONLY, ballots must be received by **November 9th, 2024**. Sign your identification envelope by the close of polls on Election Day or return in person by **7:30 p.m. on Election Day**.

**Near relative includes the voter's spouse or the voter's father, mother, father-in-law, mother-in-law, grandfather, grandmother, brother, or sister of the whole or half blood, or the son, daughter, adopting parent, adopted child, stepparent, stepchild, uncle, aunt, nephew, or niece.*
