NEXT STEPS

- Once the board of elections receives your absentee vote by mail application, the board will process your request and mail your ballot beginning **April 8th**, **2025** to your address.
- You can track your ballot online at votehamiltoncountyohio.gov
- If you return your absentee ballot by mail, it must be postmarked no later than May 5th, 2025 and received by the board of elections no later than May 10th, 2025. By state law, a postmark does NOT include a date marked by a postage evidence system such as a postage meter.
- If you return your ballot to the board in person, you must do so by **7:30 p.m. on Election Day.**
- Only you, your spouse, child, or a near relative* may deliver your ballot to the board of elections for you.
- A disabled voter may select any person of their choosing to deliver their ballot, other than their employer or an officer in their union.
- The person delivering the ballot for a family member or disabled voter must complete an attestation form at the county board of elections office (Form 12-P)
- For members of the uniformed services or voters outside of the United States ONLY, ballots must be received by May 10th, 2025. Sign your identification envelope by the close of polls on Election Day or return in person by 7:30 p.m. on Election Day.

^{*}Near relative includes the voter's spouse or the voter's father, mother, father-in-law, mother-in-law, grandfather, grandmother, brother, or sister of the whole or half blood, or the son, daughter, adopting parent, adopted child, stepparent, stepchild, uncle, aunt, nephew, or niece.
